Berry's Tin Shop, Inc Galvalume Limited Warranty

Berry's Tin Shop warrants to the buyer that Berry's Tin Shop's hot dipped aluminum-zinc alloy coated Galvalume (TM) sheet steel sold for use as unpainted steel building roofing and siding panels, if erected within the United States, will not rupture, fail structurally, or perforate within a period of 25 years after shipment from Berry's Tin Shop due to exposure to normal environment conditions.

This warranty DOES NOT APPLY to sheets exposed at any time to corrosive or aggressive environmental conditions, including but not limited to:

- 1. Areas subject to salt water marine atmospheres or constant spraying of either salt or fresh water.
- Areas subject to fallout or exposure to corrosive chemicals, fumes, ash, cement dust, animal
 waste, or it's decomposition by-products, carbon black, or fallout from copper, lead, nickel or silver
 mining or refining operations.
- 3. Areas subject to water run-off from lead or copper flashings or areas where the Galvalume sheet is in contact with lead or copper.
- 4. Conditions / circumstances where corrosive fumes or condensates are generated or released inside the building.

This warranty DOES NOT APPLY in the event of:

- A. Bends less than 2T inside bend diameter for sheet thickness 0.030" and thinner, and less than 4T for sheet thickness 0.031 and thicker.
- B. Slopes of the roof or sections of the roof flatter than 1/4:12.
- C. Mechanical, chemical or other damage sustained during shipment, storage, forming, fabrication, or erection.
- D. Forming which incorporates severe bending or which subjects the metallic coating to alternate compression and tension.
- E. Failure to provide free drainage of water, including internal condensation, from overlaps and all other surfaces of sheets or panels.
- F. Failure to remove debris such as dirt, leaves, and rubbish from overlaps and all other surfaces of sheets or panels.
- G. Damage caused to the metallic coating by improper forming, scouring or cleaning procedures.
- H. Deterioration of the panels caused by contact with green, wet or pressure treated lumber or wet storage stain caused by water or condensation.
- I. Presence of damp insulation, soil vegetation, or other corrosive material in contact with or in close proximity to the panel.
- J. Deterioration to the panels caused directly or indirectly by panel contact with fasteners. Selection of suitable long-lasting fasteners to be used with Galvalume roofing or siding panels rest solely with the Buyer. Fasteners are to be insulated from panel surface (elastomic grommets) to prevent dissimilar metal contact
- K. Failure caused by God, falling objects, external forces, explosions, fires, riots, civil commotions, acts of war or radiation.

- L. Failure due to use in manner not intended or improper storage or handling.
- M. Failure due to edge corrosion or misapplication of Berry's Tin Shop's materials.
- N. Drilling of stack panels, and failure to remove shavings from surface of panels from fastener application.

This warranty shall be subject to the stipulations, and conditions hereinafter set forth:

- 1. Berry's Tin Shop's liability for breach of this warranty shall be limited exclusively to the cost of either repairing nonconforming panels, or at Berry Tin Shop's sole option replacing nonconforming panels.
- Berry's Tin Shop shall not in any event be liable for the cost of labor expended by others on any nonconforming sheet or for any special, indirect or consequential damages to anyone by reason of the fact that such panels are nonconforming.
- 3. This warranty also applies to the material repaired or used to replace the nonconforming material, but only for the unexpired portion of the warranty period applicable to the original material.
- 4. Claims must be reported in writing to Berry's Tin Shop during the warranty period and not more than thirty (30) days after detection of any apparent defects and Berry's Tin Shop shall be given a reasonable opportunity to inspect the panels claimed to be nonconforming. Adequate identification of the material involved in the claim, including date of installation, Berry's Tin Shop order number, and invoice number, must be established by Buyer.
- 5. Buyer shall exercise diligence in his inspection of sheets as received from Berry's Tin Shop so as to mitigate repair or replacement.
- 6. Berry's Tin Shop extends this warranty solely to the Buyer. This warranty is nontransferable and non- assignable.
- 7. Berry's Tin Shop reserves the right to terminate this warranty at any time (except as to orders already accepted).
- 8. Berry's Tin Shop shall have no obligations under this warranty unless and until it receives payment in full for materials furnished.
- 9. The supplier of the Galvalume substrate has made certain warranties to Berry's Tin Shop which are same (or substantially similar) as the warranties made by Berry's Tin Shop under this limited warranty. This limited warranty shall be of no further force or effect if such supplier, or it's successors or assigns, can no longer perform it's obligations under the Galvalume warranties made to Berry's Tin Shop.

BERRY'S TIN SHOP MAKES NO GUARANTEES, EITHER EXPRESS OR IMPLIED OTHER THAN AS STATED HEREIN, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF FITNESS AND MERCHANTABILITY OR FITNESS FOR ANY PURPOSE. BERRY'S TIN SHOP SHALL NOT BE RESPONSIBLE FOR ANY INDIRECT OR CONSEQUENTIAL DAMAGES OR ANY LOSS OF ANY KIND WHATSOEVER.
